MARKET UPDATE: NAVIGATING MARKET VOLATILITY WITH CONFIDENCE

Global markets have been more unpredictable recently, driven by ongoing geopolitical uncertainty in regions such as Ukraine, Venezuela, and Greenland, along with higher tariffs announced in April 2025 and again in January 2026. These developments have contributed to increased market swings and rising commodity prices as investors react to changing global conditions and policy decisions. While this kind of volatility can feel uncomfortable, it is not unusual during periods of economic and political transition.

History shows that markets often experience short-term volatility following tariff increases, as investors adjust to new trade dynamics and reassess economic growth expectations. In past instances, including prior periods of elevated trade tensions, initial market reactions were frequently driven by uncertainty and emotion rather than long-term fundamentals. Over time, investors who remained focused on diversification and their long-term strategy were often better positioned than those who made decisions based on short-term headlines.

During times like these, it can be helpful to focus on what you can control. Reviewing your portfolio, staying diversified, and making sure your investments align with your time horizon and comfort with risk are all important steps. If recent news or market movements are causing concern, this may be a good opportunity to reconnect with your advisor, revisit your financial plan, and talk through any questions. Thoughtful, proactive conversations can help provide confidence and perspective during uncertain market environments.

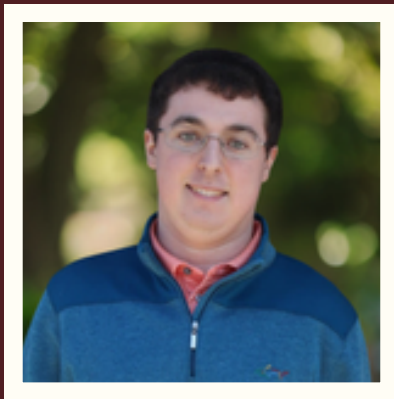

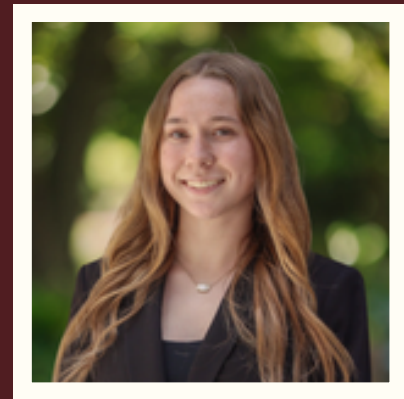

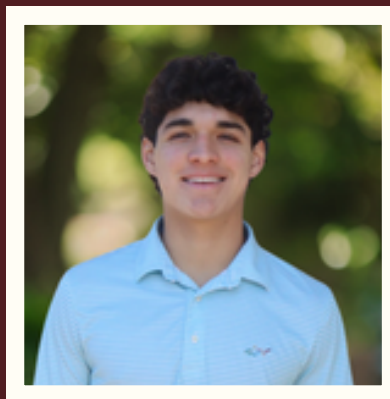
